**RESOLUTION DECLARING 168 SECURITY SERVICES AS THE SINGLE, CALCULATED/RATED AND  
RESPONSIVE BID AND RECOMMENDING TO  
THE APPROVING AUTHORITY THE APPROVAL THEREOF**

**WHEREAS**, the Bureau of Broadcast Services (BBS), in order to maintain security services for its central and regional offices, posted on the PhilGeps website an Invitation to Bid (ITB) for the provision of Security Service Provider for BBS under 'Lot 009-17' on November 23, 2017, published it on the Philippine Star on November 25, 2017, and posted the same on the PBS website, with an Approved Budget for Contract (ABC) of **SIXTEEN MILLION SIX HUNDRED ONE THOUSAND PESOS (P16,601,000.00)**;

**WHEREAS**, in response to the said advertisement, three (3) prospective bidders, namely, Achievers Security Agency Phils, 168 Security Services, and Centara Security Services Corporation, viewed the Bid Documents at the PhilGeps website;

**WHEREAS**, a pre-bid conference was held on December 1, 2017, 10:25AM, where the BAC clarified matters with the prospective bidders in attendance, namely, 168 Security Services and Hackett Security Agency;

**WHEREAS**, on December 13, 2017, at 10:10AM, the opening of bids was conducted, where one (1) prospective bidder participated, namely, 168 Security Services;

**WHEREAS**, the envelopes of 168 Security Services were opened by Julius Gonzales, BAC Secretariat Member. BAC Chairperson, Ms Elizabeth Raymundo, went through each of the checklist items while the BAC members reviewed the submitted documents. Each item was marked "Pass" or "Not Applicable," as the case may be, per review and evaluation of the BAC members. After reading all the items in the Class A and B Eligibility Documents, the Chairperson declared the Eligibility Documents of 168 Security Services as **ELIGIBLE**;

**WHEREAS**, the Financial Documents of 168 Security Services were then opened and showed its bid amount at **SIXTEEN MILLION FIVE HUNDRED SIXTY NINE THOUSAND THREE HUNDRED SIX PESOS AND 72/100 (P16,569,306.72)**; as compared to the ABC at **SIXTEEN MILLION SIX HUNDRED ONE THOUSAND PESOS (P16,601,000.00)**;

**WHEREAS**, the 168 Security Services was thus declared by Ms Raymundo as the Single, Calculated/Rated and Responsive Bid subject to Post Qualification;

**WHEREAS**, Chairperson Raymundo asked the 168 Security Services representative if she is available for the Post Qualification date on December 15, 2017 in the morning, and she answered in the affirmative;

**WHEREAS**, the composite team of BAC, TWG and Secretariat conducted Post-Qualifications Inspection of 168 Security Services on December 15 2017, where the Post-qualification requirements of 168 Security Services were verified, validated and were all found to be true and correct and in accordance with the requirements and inspection activities;

NOW, THEREFORE, the Bureau of Broadcast Services – Bids and Awards Committee (BBS-BAC) **HEREBY RESOLVES**, as it is **HEREBY RESOLVED**, to declare **168 SECURITY SERVICES** as having the Single, Calculated/Rated and Responsive Bid for Security Services of the BBS central and regional offices; and,

**RESOLVED FURTHER**, that the Bureau of Broadcast Services – Bids and Awards Committee (BBS-BAC) recommends to the Approving Authority the **Approval** of this resolution, the subsequent issuance of the Notice of Award, and to enter into an agreement with **168 SECURITY SERVICES** for Security Services for a period of One (1) Year to be posted in the BBS Central Office in the amount of **SIXTEEN MILLION FIVE HUNDRED SIXTY NINE THOUSAND THREE HUNDRED SIX PESOS AND 72/100 (P16,569,306.72)**, in accordance with the provisions of signed contract of services and the Guidelines under the Government Procurement Reform Act, as approved and adopted by the Government Procurement Policy Board (GPPB).

Let copies of this Resolution be posted at the PBS website, and at a conspicuous place inside the PBS-BBS premises.


