**RESOLUTION DECLARING CMPT MANPOWER SERVICES AS THE SINGLE, CALCULATED/RATED
AND RESPONSIVE BID AND RECOMMENDING TO
THE APPROVING AUTHORITY THE APPROVAL THEREOF**

WHEREAS, the Bureau of Broadcast Services (BBS), in order to maintain manpower services for its central office, posted on the PhilGeps website an Invitation to Bid (ITB) for the provision of Manpower Service Provider for BBS under 'Lot 010-17' on November 24, 2017, published it on the Philippine Star on November 25, 2017, and posted the same on the PBS website, with an Approved Budget for Contract (ABC) of **THREE MILLION THREE HUNDRED TWENTY SIX THOUSAND PESOS (P3,326,000.00)**;

WHEREAS, in response to the said advertisement, six (6) prospective bidders, namely; Hire and Keep Inc.; Energy Manpower Services, Inc., Starcom Manpower and Allied Services, Inc.; The Perfect Cleaners Janitorial Sales and Services; Excellent General Services, and CMPT Manpower Services, viewed the Bid Documents at the PhilGeps website;

WHEREAS, a pre-bid conference was held on December 1, 2017, 11:00AM, where the BAC clarified matters with the prospective bidders in attendance, namely Hire and Keep Inc.; The Perfect Cleaners; M8 Manpower Services; CMPT Manpower Services; and Energy Manpower Services, Inc.;

WHEREAS, on December 13, 2017, at 10:30AM, the opening of bids was conducted, where one (1) prospective bidder participated, namely, CMPT Manpower Services;

WHEREAS, the envelopes of CMPT Manpower Services were opened by Mr Andrecito Poblete, TWG Head, BAC Chairperson, Ms Elizabeth Raymundo, went through each of the checklist items while the BAC members reviewed the submitted documents. Each item was marked "Pass" or "Not Applicable," as the case may be, per review and evaluation of the BAC members. After reading all the items in the Class A and B Eligibility Documents, the Chairperson declared the Eligibility Documents of CMPT Manpower Services, Inc. as **ELIGIBLE**;

WHEREAS, the Financial Documents of CMPT Manpower Services were then opened and showed its bid amount at **THREE MILLION THREE HUNDRED TWENTY FIVE THOUSAND SIX HUNDRED FIFTY SEVEN PESOS AND 33/100 (P3,325,657.33)**; as compared to the ABC at **THREE MILLION THREE HUNDRED TWENTY SIX THOUSAND PESOS (P3,326,000.00)**;

WHEREAS, the CMPT Manpower Services was thus declared by Ms Raymundo as the Single, Calculated/Rated and Responsive Bid subject to Post Qualification;

WHEREAS, Chairperson Raymundo asked CMPT Manpower Services representatives if they are available for the Post Qualification date on December 15, 2017 in the afternoon; they answered in the affirmative;

WHEREAS, the composite team of BAC, TWG and Secretariat conducted Post-Qualifications Inspection of CMPT Manpower Services on December 15 2017, where the Post-qualification requirements of CMPT Manpower Services were verified, validated and were all found to be true and correct and in accordance with the requirements and inspection activities;

NOW, THEREFORE, the Bureau of Broadcast Services – Bids and Awards Committee (BBS-BAC) **HEREBY RESOLVES**, as it is **HEREBY RESOLVED**, to declare **CMPT MANPOWER SERVICES** as having the Single, Calculated/Rated and Responsive Bid for Manpower Services of the BBS central office; and,

RESOLVED FURTHER, that the Bureau of Broadcast Services – Bids and Awards Committee (BBS-BAC) recommends to the Approving Authority the **Approval** of this resolution, the subsequent issuance of the Notice of Award, and to enter into an agreement with **CMPT MANPOWER SERVICES** for Manpower Services for a period of One (1) Year to be posted in the BBS Central Office in the amount of **THREE MILLION THREE HUNDRED TWENTY FIVE THOUSAND SIX HUNDRED FIFTY SEVEN PESOS AND 33/100 (P3,325,657.33)**, in accordance with the provisions of signed contract of services and the Guidelines under the Government Procurement Reform Act, as approved and adopted by the Government Procurement Policy Board (GPPB).

Let copies of this Resolution be posted at the PBS website, and at a conspicuous place inside the PBS-BBS premises.




