**BBS BIDS AND AWARDS COMMITTEE RESOLUTION DECLARING 168 SECURITY INC. AS THE
SINGLE CALCULATED/RATED RESPONSIVE BID AND RECOMMENDING TO THE APPROVING
AUTHORITY THE APPROVAL THEREOF**

WHEREAS, the Bureau of Broadcast Services, (BBS), in order to maintain security services for all its offices nationwide, advertised through the Bids and Awards Committee (BAC) the invitation to Bid (ITB) for the provision of security services in a newspaper of nationwide circulation namely: The Philippine Star on May 24, 2017 and posted the complete Bidding Documents in the Philippine Government Electronic Procurement System (PhilGEPS) Website;

WHEREAS, in response to the said advertisement, some prospective bidders namely: **168 SECURITY INC., COMMANDER SECURITY SERVICES INC.** and **DBPSC SEC** downloaded the Bidding Documents at the PhilGEPS Website. During the Pre-Bid Conference on June 1, 2017, representatives from **168 SECURITY INC., COMMANDER SECURITY SERVICES** and **DBPSC SEC** were present where the BAC clarified issues raised by the prospective bidders.

WHEREAS, On June 14, 2017 at 10:00 AM, the opening of the bids was conducted. **168 SECURITY INC.**, the lone bidder (who purchased the Bidding Document), submitted its Eligibility and Technical Components Documents as well as its Financial Component Document.

WHEREAS, the bidding process was completed within the day and found the Eligibility and Technical Components Documents of **168 SECURITY INC** to have **PASSED** and was declared **ELIGIBLE** after its itemized contents were read aloud and subsequently shown thru the multi-media projector, after which its Financial Component Document was opened and read aloud and subsequently shown thru the multi-media projector, and was found to be a **RESPONSIVE BID**;

WHEREAS, the BAC in a meeting held after the opening and evaluation of BID, discussed immediately the parameters for the post qualification stage and named the composite group of selected BAC, TWG and Secretariat who will conduct the said inspection.

WHEREAS, the composite group of selected BAC, TWG and Secretariat on June 15, 2017 proceeded to the office of **168 SECURITY INC.** and conducted the post qualification inspection of its Eligibility and Technical Components Documents, counterchecked said documents with the original documents, inspected the office premises, training facilities and its armory and certain issues and concerns were also raised. **168 SECURITY INC.**, likewise submitted the Post Qualification Documents listed in the Bid and presented the checklist of post qualification requirements which were verified and validated and all were found to be true and correct and in accordance with the requirements and inspection activities undertaken jointly by the BAC, Technical Working Group (TWG) and Secretariat.

NOW , THEREFORE, the Bureau of Broadcast Services – Bids and Awards Committee (BBS-BAC) hereby resolves, as it is hereby resolved, to declare **168 SECURITY INC.** as having the Single Calculated/Rated and Responsive Bid for the supply of fifty five (55) security guards for the Bureau of Broadcast Services (BBS) offices nationwide; and


RESOLVED FURTHER, that the BBS-BAC recommends to the Approving Authority the approval of this resolution, the subsequent issuance of the Notice of Award, and to enter into an agreement with **168 SECURITY INC.** for security services of fifty five (55) security guards to be

posted in predetermined areas in the amount of **SEVEN MILLION EIGHT HUNDRED EIGHTY SIX THOUSAND EIGHT HUNDRED FORTY TWO PESOS AND 92/100 (Php7,886,842.92)** for a period of **six (6)** months in accordance with the provisions of signed contract of services and the Guidelines under 2016 Revised Implementing Rules and Regulation (IRR) of Republic Act 9184 otherwise known as The Government Procurement Reform Act, as approved and adopted by the Government Procurement Policy Board (GPPB).
