

BAC AMP RESOLUTION No. 342 Series of 2018

BIDS AND AWARDS COMMITTEE (BAC) RESOLUTION RECOMMENDING SECTION 53.1 TWO FAILED BIDDINGS OF THE 2016 REVISED IMPLEMENTING RULES AND REGULATIONS OF RA 9184 OTHERWISE KNOWN AS THE 'GOVERNMENT PROCUREMENT REFORM ACT AS AN ALTERNATIVE MODE OF PROCUREMENT

WHEREAS, Sec. 48, Rule XVI of the Revised IRR of R.A. 9184, otherwise known as the 'Government Procurement Reform Act provides that in order to promote economy and efficiency, the procuring entity may resort to any of the alternative methods of procurement which are Limited Source Bidding, Direct Contracting, Repeat Order, Shopping and Negotiated Procurement, provided that the most advantageous price for the government will be obtained;

WHEREAS, the Bids and Awards Committee (BAC) conducted two (2) failed public biddings for the One (1) Lot - Supply and Delivery of One (1) Unit Brand New Passenger Van, the first scheduled Opening of Bids for Bid No. 003-18 was held last 10 April 2018, no bidders purchased the bidding documents and participated, while the second scheduled Opening of Bids for Bid No. 005-18 was held last 21 May 2018, the lone bidder failed on one (1) of its eligibility requirements —"Technical Specifications: Item A"— it was found to be patently insufficient and has FAILED the Bid Evaluation and was declared "INELGIBLE";

WHEREAS, the second failure of bidding for the procurement of One (1) Lot - Supply and Delivery of One (1) Unit Brand New Passenger Van was declared by the Bids and Awards Committee (BAC) in BAC AMP Resolution No 206 series of 2018;

WHEREAS, Section 35.1 of the 2016 Revised Implementing Rules and Regulations of R.A. 9184, provides that the BAC shall declare the bidding a failure when (a) No bids are received; and (b) all prospective bidders are declared ineligible;

WHEREAS, Section 35.5 provides that should there occur a second failure of bidding, the Procuring Entity may resort to negotiated procurement, as provided for in Section 53.1 of the Revised IRR;

WHEREAS, Section 53 of the 2016 Revised IRR of R.A. 9184, allows an agency to resort to Negotiated Procurement, a method of procurement of Goods, Infrastructure Projects and Consulting Services whereby the Procuring Entity directly negotiates a contract with a technically, legally and financially capable supplier, contractor or consultant:

WHEREAS, Section 53.1 of the Revised IRR of RA 9184 allows an agency to resort to SECTION 53.1 TWO FAILED BIDDINGS where there has been failure of competitive bidding or limited source bidding for the second time as provided in Section 35 of the Act and the Revised IRR;

WHEREAS, the Bids and Awards Committee (BAC) was created in accordance with BBS Memorandum Order No. 006 series of 2018;

WHEREAS, the BAC conducted a mandatory review of the terms, conditions, specifications and cost estimates as prescribed in Section 35 of the IRR, the Bids and Wards Committee (BAC) together with its Secretariat, TWG and End-User agreed to revised the technical specifications and adjust the current Approved Budget for the Contract (ABC) subject to the approval of the HoPE;

WHEREAS, the BAC agreed to recommend to the HoPE the revision of the technical specifications and adjustment of the current Approved Budget for the Contract (ABC) from the amount of One Million Four Hundred Ninety Thousand Pesos (PhP 1,490,000.00) to One Million Five Hundred Thousand Pesos (PhP 1,500,000.00);

WHEREAS, the BAC upon review of the attached PURCHASE REQUEST NO. 2018-06-0248 the BAC finds that the above conditions for SECTION 53.1 TWO FAILED BIDDINGS are satisfied;
