BIDS AND AWARDS COMMITTEE (BAC) RESOLUTION DECLARING FAILURE OF BIDDING FOR THE PROCUREMENT OF ONE (1) LOT - SUPPLY AND DELIVERY OF FOUR (4) UNITS BRAND NEW PICK-UP AND RECOMMENDING TO THE APPROVING AUTHORITY THE APPROVAL THEREOF

WHEREAS, there is an approved Purchase Request (P.R.) No. **2018-03-0162** with an Approved Budget for the Contract (ABC) of Four Million Seven Hundred Fifty Thousand Pesos (PhP 4,750,000.00) for the procurement of One (1) Lot - Supply and Delivery of Four (4) Units Brand New Pick-up;

WHEREAS, the Bids and Awards Committee (BAC) was created in accordance with BBS Memorandum Order No. 005 series of 2018 dated 02 March 2018;

WHEREAS, the Bids and Awards Committee (BAC) was authorized to resort to Public Bidding in accordance with the provision of Rule IV, Section 10, Competitive Bidding of the 2016 Revised IRR of R.A. 9184, otherwise known as the Government Procurement Reform Act which states that all procurement shall be done through competitive bidding, except as provided in Rule XVI of the Revised IRR of R.A. 9184;

WHEREAS, on 14 March 2018 the Bids and Awards Committee (BAC) conducted a Pre-Procurement Conference;

WHEREAS, on 19 March 2018 the Bids and Awards Committee (BAC) advertised/posted the Invitation to Bid and the complete set of Bidding Documents in the Philippine Government Electronic Procurement System (PHILGEPS) Website;

WHEREAS, in response to the said advertisement, Six (6) prospective bidders viewed the Invitation to Bid at the PHILGEPS Website namely; TOYOTA MAKATI INC., TOYOTA QUEZON AVE INC., UNITED ASIA AUTOMOTIVE GROUP INC., DIAMOND MOTOR CORPORATION, NISSAN COMMONWEALTH INC. AND NISSAN UN AVENUE MANILA;

WHEREAS, the Bids and Awards Committee (BAC) scheduled the Pre-Bid Conference on 27 March 2018 at 10:00AM in order that the BAC may clarify issues which the prospective bidders might raise, the said Pre-Bid Conference was attended by the following, namely; TOYOTA NORTH EDSA, NISSAN COMMONWEALTH AND DMC-EDSA MITSUBISHI;

WHEREAS, on 10 April 2018 at 10:00AM, the Bids and Awards Committee (BAC) scheduled the Opening of Bids, no bidders purchased the bidding documents and participated on the scheduled Opening of Bids;

WHEREAS, Section 35.1 (a) of the 2016 Revised Implementing Rules and Regulations of R.A. 9184, provides that the BAC shall declare the bidding a failure when no bids are received;

WHEREAS, Section 35.2 provides that in order to determine the reason for the failed bidding, the BAC shall conduct a mandatory review and evaluation of the terms, conditions and specifications in the Bidding Documents, including its cost estimates;

WHEREAS, Section 35.3 of the same Act, provides that the BAC based on its findings shall revised the terms, conditions and specifications and if necessary, adjust the ABC, subject to the required approvals and shall conduct a re-bidding with re-advertisement and/or posting, as provided for in Section 21.2 of the Revised IRR;

NOW, THEREFORE, foregoing premises considered, we the members of the Bids and Awards Committee (BAC), hereby **RESOLVE**, as it is hereby **RESOLVED**, to **RECOMMEND** for the approval of the Director of the Bureau of Broadcast Services (BBS) the Declaration of failure of bidding and the conduct of re-bidding for the procurement of One (1) Lot - Supply and Delivery of Four (4) Units Brand New Pick-up in the amount of *Four Million Seven Hundred Fifty Thousand Pesos (PhP 4,750,000.00)*;


