BIDS AND AWARDS COMMITTEE (BAC) RESOLUTION DECLARING SECOND FAILURE OF BIDDING AND TO RESORT THROUGH NEGOTIATED PROCUREMENT UNDER 53.1 TWO FAILED BIDDINGS THE PROCUREMENT OF ONE (1) LOT - SUPPLY AND DELIVERY OF ONE (1) UNIT BRAND NEW PASSENGER VAN AND RECOMMENDING TO THE APPROVING AUTHORITY THE APPROVAL THEREOF

WHEREAS, there is an approved Purchase Request (P.R.) No. **2018-03-0164** with an Approved Budget for the Contract (ABC) of One Million *Four Hundred Ninety Thousand Pesos (PhP 1,490,000.00)* for the procurement of One (1) Lot - Supply and Delivery of One (1) Unit Brand New Passenger Van;

WHEREAS, the Bids and Awards Committee (BAC) was created in accordance with BBS Memorandum Order No. 006 series of 2018;

WHEREAS, the Bids and Awards Committee (BAC) was authorized to resort to Public Bidding in accordance with the provision of Rule IV, Section 10, Competitive Bidding of the 2016 Revised IRR of R.A. 9184, otherwise known as the Government Procurement Reform Act which states that all procurement shall be done through competitive bidding, except as provided in Rule XVI of the Revised IRR of R.A. 9184;

WHEREAS, the Bids and Awards Committee (BAC) conducted the first scheduled Opening of Bids for the procurement of Bid No. 003-18 - One (1) Lot - Supply and Delivery of One (1) Unit Brand New Passenger Van last 10 April 2018, no bidders purchased the bidding documents and participated on the scheduled Opening of Bids;

WHEREAS, in a BAC Resolution dated 19 April 2018, the Bids and Awards Committee (BAC) recommend for the approval of the Director of the Bureau of Broadcast Services the declaration of failure of bidding for Bid No. 003-18 - One (1) Lot - Supply and Delivery of One (1) Unit Brand New Passenger Van and the conduct of re-bidding;

WHEREAS, on the same BAC Resolution, the Director of the Bureau of Broadcast Services approved the Declaration of failure of bidding and the conduct of re-bidding;

WHEREAS, on 24 April 2018 the Bids and Awards Committee (BAC) conducted a Pre-Procurement Conference for Bid No. 005-18 - One (1) Lot - Supply and Delivery of One (1) Unit Brand New Passenger Van;

WHEREAS, on 27 April 2018 the Bids and Awards Committee (BAC) advertised/posted the Invitation to Bid and the complete set of Bidding Documents in the Philippine Government Electronic Procurement System (PHILGEPS) Website;

WHEREAS, as of 21 May 2018, no prospective bidder viewed the invitation to Bid at the PHILGEPS Website;

WHEREAS, for the purposes of transparency and good governance and pursuant to Section 13 of the 2016 Revised Implementing Rules and Regulations of Republic Act No. 9184, the Bids and Awards Committee (BAC) invited three (3) observers to witness the pre-bid conference on 07 May 2018 and the opening of bids on 21 May 2018 namely; Mr. Crisanto Frianeza, Secretary General of the Philippine Chamber of Commerce and Industry, Rev. F. Eli Lumbo, SJ. Executive Director of the Philippine Jesuit Prison Service and Ms. Fe O. Balerite, Audit Team Leader/PBS-BBS Resident Auditor of the Commission on Audit;

WHEREAS, the Bids and Awards Committee (BAC) scheduled the Pre-Bid Conference on 07 May 2018 at 10:00AM in order that the BAC may clarify issues which the prospective bidders might raise, the said Pre-Bid Conference was attended by the following, namely; HYUNDAI COMMONWEALTH and TOYOTA QUEZON AVENUE;

WHEREAS, One (1) prospective bidder namely; HYUNDAI COMMONWEALTH purchased the Bidding Documents;

WHEREAS, the Bids and Awards Committee (BAC) scheduled the Opening of Bids on 21 May 2018 at 10:30AM, HYUNDAI COMMONWEALTH attended and submitted its Eligibility and Technical Components Documents as well as its Financial Component Document before the 10:30AM deadline and simultaneously, the BAC conducted the Opening of Bids;


