BIDS AND AWARDS COMMITTEE (BAC) RESOLUTION DECLARING FAILURE OF BIDDING FOR THE PROCUREMENT OF NINE (9) MONTHS LEASE OF TOWER LOT FROM APRIL TO DECEMBER 2019 FOR DWFR - RADYO PILIPINAS 1 - BONTOC AND RECOMMENDING TO THE APPROVING AUTHORITY THE APPROVAL THEREOF

WHEREAS, there is an approved Job Order (J.O.) No. 2019-02-0008 with an Approved Budget for the Contract (ABC) of One Hundred Eighty Six Thousand Five Hundred Forty Three Pesos (PhP 186,543.00) for the procurement of the following listed below;

WHEREAS, the Bids and Awards Committee (BAC) was created in accordance with BBS Memorandum Order No. 006 series of 2018;

WHEREAS, the said Job Order is included in the Annual Procurement Plan of the Philippine Broadcasting Service-Bureau Services (PBS-BBS) for 2019;

WHEREAS, the Bids and Awards Committee (BAC) was authorized to resort to Public Bidding in accordance with the provision of Rule IV, Section 10, Competitive Bidding of the 2016 Revised IRR of R.A. 9184, otherwise known as the Government Procurement Reform Act which states that all procurement shall be done through competitive bidding, except as provided in Rule XVI of the Revised IRR of R.A. 9184;

WHEREAS, on 12 February 2019 the Bids and Awards Committee (BAC) conducted a Pre-Procurement Conference;

WHEREAS, on 14 February 2019 the Bids and Awards Committee (BAC) advertised/posted the Invitation to Bid and the complete set of Bidding Documents in the Philippine Government Electronic Procurement System (PHILGEPS) Website and at the Philippine Broadcasting Services-Bureau of Broadcast Services Website;

WHEREAS, in response to the said advertisement, no prospective bidder viewed the Invitation to Bid at the PHILGEPS Website;

WHEREAS, for the purposes of transparency and good governance and pursuant to Section 13 of the 2016 Revised Implementing Rules and Regulations of Republic Act No. 9184, the Bids and Awards Committee (BAC) invited three (3) observers to witness the pre-bid conference on 23 October 2018 and the opening of bids on 06 November 2018 namely; MR. CRISANTO FRIANEZA, Secretary General of Philippine Chamber of Commerce and Industry, MR. AMADOR ASTUDILLO, President of Procurement Watch and MS. ANNABELLE F. DE VERA, State Auditor III/Audit Team Leader in BBS of Commission on Audit;

WHEREAS, the Bids and Awards Committee (BAC) scheduled the Pre-Bid Conference on 22 February 2019 at 10:30AM in order that the BAC may clarify issues which the prospective bidders might raise, nevertheless, no bidder attended the Pre-Bid Conference;

WHEREAS, on 04 March 2019 one (1) prospective bidder purchased the bidding document, namely: MR. DOMINIC LEFONG;

WHEREAS, on 06 March 2019, the Bids and Awards Committee (BAC) scheduled the Opening of Bids at 11:00AM, no bidder participated on the scheduled Opening of Bids;

WHEREAS, Section 35.1 (a) of the 2016 Revised Implementing Rules and Regulations of R.A. 9184, provides that the BAC shall declare the bidding a failure when no bids are received;

NOW, THEREFORE, foregoing premises considered, we the members of the Bids and Awards Committee (BAC), hereby RESOLVE, as it is hereby RESOLVED, to RECOMMEND for the approval of the Director of the Bureau of Broadcast Services (BBS) the Declaration of failure of bidding for the procurement of NINE (9) MONTHS LEASE OF TOWER LOT FROM APRIL TO DECEMBER 2019 FOR DWFR - RADYO PILIPINAS 1 - BONTOC in the amount of One Hundred Eighty Six Thousand Five Hundred Forty Three Pesos (PhP 186,543.00);
