BIDS AND AWARDS COMMITTEE (BAC) RESOLUTION DECLARING CMPT MANPOWER SERVICES AS HAVING THE SINGLE CALCULATED AND RESPONSIVE BID FOR THE ONE (1) LOT – CONTRACT FOR THE PROVISION OF MANPOWER SERVICE PROVIDER FOR ELEVEN (11) MONTHS AND RECOMMENDING TO THE APPROVING AUTHORITY THE APPROVAL THEREOF

WHEREAS, there is an approved Purchase Request (P.R.) Nos. 2019-12-0352 with an Approved Budget for the Contract (ABC), in the amount of *Four Million Five Hundred Fifty Eight Thousand Seven Hundred Pesos (Php 4,558,700.00)* as listed hereunder;

WHEREAS, the Bureau of Broadcast Services-Bids and Awards Committee (BBS-BAC) was authorized to resort to Public Bidding in accordance with the provision of Rule IV, Section 10, Competitive Bidding of the 2016 Revised IRR of R.A. 9184, otherwise known as the Government Procurement Reform Act which states that all procurement shall be done through competitive bidding, except as provided in Rule XVI of the Revised IRR of R.A. 9184;

WHEREAS, the BBS-BAC was created in accordance with BBS Memorandum Order No. 006 series of 2018;

WHEREAS, the BBS-BAC convened on 09 December 2019 to conduct a pre-procurement conference with the End-User in accordance with the provision of Section 20 of the 2016 Revised Implementing Rules and Regulations of Republic Act No. 9184;

WHEREAS, on 12 December 2019, the BBS-BAC as mandated by Republic Act No 9184, posted the Invitation to Bid for the Bid No. 014-19 - One (1) Lot – Contract for the Provision of Manpower Service Provider for eleven (11) months in the Philippine Government Electronics Procurement System (PHILGEPS), on conspicuous place at the premises of the BBS and posted the same in the website of the Bureau of Broadcast Services;

WHEREAS, in response to the said advertisement, three (3) prospective bidders viewed the Invitation to Bid at the PHILGEPS Website namely; 1) ANCHOR HUMAN RESOURCE DEVELOPMENT CORPORATION, 2) EXCELLENT GENERAL SERVICES, INC., & 3) CMPT MANPOWER SERVICES;

WHEREAS, for the purposes of transparency and good governance and pursuant to Section 13 of the 2016 Revised Implementing Rules and Regulations of Republic Act No. 9184, the Bids and Awards Committee (BAC) invited three (3) observers to witness the pre-bid conference on 25 October 2019 and the opening of bids on 06 November 2019 namely; MR. CRISANTO FRIANEZA, Secretary General of Philippine Chamber of Commerce and Industry, ENGR. VIRGILIO S. SANTOS, President of Procurement Watch and MS. ANNABELLE F. DE VERA, State Auditor III/Audit Team Leader in BBS of Commission on Audit;

WHEREAS, the BBS-BAC scheduled the Pre-Bid Conference on 19 December 2019 at 10:00AM in order that the BBS-BAC may clarify issues which the prospective bidders might raise, the said Pre-Bid Conference was attended by one (1) prospective bidder, namely; 1) CMPT MANPOWER SERVICES;

WHEREAS, one (1) prospective bidder namely; 1) CMPT MANPOWER SERVICES purchased the Bidding Document;

WHEREAS, on 03 December 2020 at 10:00AM, the BBS-BAC scheduled the Opening of Bids, CMPT MANPOWER SERVICES attended and submitted its Eligibility and Technical Components Documents as well as its Financial Component Document before the 10:00am deadline and simultaneously, the BAC conducted the Opening of Bids;

WHEREAS, the BBS-BAC proceeded to open the Eligibility and Technical Documents envelope of CMPT MANPOWER SERVICES its itemized contents were read aloud and subsequently shown thru the multi-media projector and found to have passed and sufficient and was declared "ELIGIBLE";

WHEREAS, the bidding process was completed and the BBS-BAC proceeded to open the Financial Component Document of CMPT MANPOWER SERVICES in the amount of Four Million Five Hundred Fifty Five Thousand Nine Hundred Eighty Eight Pesos (PhP 4,555,988.00) and was declared by the BBS-BAC as the SINGLE RESPONSIVE BID (SRB);

WHEREAS, on the same meeting, the BBS-BAC Secretariat officially turned-over to the BAC TWG a copy of the Eligibility and Technical Documents as well as the financial document of CMPT MANPOWER SERVICES for bid evaluation;

WHEREAS, the BAC noticed that CMPT MANPOWER SERVICE already attached their post-qualification documents in their submitted technical documents;

WHEREAS, on 06 January 2020, the BAC-TWG informed the BBS-BAC that based on their evaluation conducted in the eligibility documents of the CMPT MANPOWER SERVICES it was discovered that it has "PASSED" the bid evaluation, subsequently the BBS-BAC selected the composite group of BBS-BAC, TWG and Secretariat who will conduct the post-qualification stage on 07 January 2020;

WHEREAS, the composite group of selected BAC, TWG and Secretariat on 07 January 2020 at 9:30AM, proceeded to the office of CMPT MANPOWER SERVICES in Caloocan City and conducted the post qualification inspection of its Eligibility and Technical Components Documents and Post Qualification Documents and counterchecked the same with the original documents. The team likewise inspected the office premises;

WHEREAS, the BBS-BAC Post-Qualification Composite Group verified and validated the Post-Qualification Requirements of CMPT MANPOWER SERVICES and all were found to be true and correct and in accordance with the requirements and inspection activities and the BBS-BAC declared that it has "PASSED" the post-qualification stage;

NOW, THEREFORE, foregoing premises considered, we the members of the Bureau of Broadcast Services-Bids and Awards Committee (BBS-BAC), hereby **RESOLVE**, as it is hereby **RESOLVED**, to declare **CMPT MANPOWER SERVICES** as having the Single Calculated and Responsive Bid (SCRB) for the Contract for the Provision of Manpower Service Provider for eleven (11) months, for the Bureau of Broadcast Services (BBS) facilities at the National Capital Region (NCR); and

RESOLVE FURTHER, that the Bureau of Broadcast Services-Bids and Awards Committee (BBS-BAC) recommends to the Approving Authority the approval of this resolution, the subsequent issuance of the Notice of Award, Notice to Proceed and Contract of Services with **CMPT MANPOWER SERVICES** for the Contract for the Provision of Manpower Service Provider for eleven (11) months, for the Bureau of Broadcast Services (BBS) facilities at the National Capital Region (NCR) - six (6) janitors, ten (10) drivers & four (4) office staff in the amount of **FOUR MILLION FIVE HUNDRED FIFTY FIVE THOUSAND NINE HUNDRED EIGHTY EIGHT PESOS (PhP 4,555,988.00)** in accordance with the provisions of the signed Purchase Order and the Guidelines under the Government Procurement Reform Act, as approved and adopted by the Government Procurement Policy Board (GPPB).




