BIDS AND AWARDS COMMITTEE (BAC) RESOLUTION DECLARING MANIC NIGHTNINGS EVENTS PRODUCTIONS AS HAVING THE SINGLE CALCULATED AND RESPONSIVE BID FOR THE PROCUREMENT OF SERVICES FOR THE ONE (1) LOT – EVENT ORGANIZING AND RECOMMENDING TO THE APPROVING AUTHORITY THE APPROVAL THEREOF

WHEREAS, there is an approved Job Order (J.O.) No. **2020-03-0018** with an Approved Budget for the Contract (ABC), in the amount of Fourteen Million Nine Hundred Eighty Thousand Pesos (PhP14,980,000.00) as listed hereunder;

WHEREAS, the Bureau of Broadcast Services-Bids and Awards Committee (BBS-BAC) conducted Public Bidding in accordance with the provision of Rule IV, Section 10, Competitive Bidding of the 2016 Revised IRR of R.A. 9184, otherwise known as the Government Procurement Reform Act which states that all procurement shall be done through competitive bidding, except as provided in Rule XVI of the Revised IRR of R.A. 9184;

WHEREAS, the BBS-BAC was created in accordance with BBS Memorandum Order No. 006 series of 2018;

WHEREAS, the BBS-BAC convened on 27 May 2020 to conduct a pre-procurement conference with the End-User in accordance with the provision of Section 20 of the 2016 Revised Implementing Rules and Regulations of Republic Act No. 9184;

WHEREAS, on 05 June 2020, the BBS-BAC as mandated by Republic Act No 9184, posted the Invitation to Bid for the **Procurement of Services for the One (1) Lot –Event Organizing (Bid No. 001-2020)** in the Philippine Government Electronics Procurement System (PHILGEPS), on conspicuous place at the premises of the BBS and posted the same in the website of the Bureau of Broadcast Services;

WHEREAS, in response to the said advertisement, fifteen (15) prospective bidders viewed the Invitation to Bid at the PHILGEPS Website namely; 1) BUSINESS UNUSUAL MEDIA SOLUTIONS, INC., 2) IMAGINIMAGE CORPORATION, 3) ECHOCHANNELS INC., 4) CITYNEON PHILIPPINES, INC., 5) MANIC NIGHTNINGS EVENTS PRODUCTIONS, 6) RADIO MINDANAO NETWORK, INC., 7) ADROW CREATIVES, INC., 8) VISUALCORE, INC., 9) PROJECT V MEDIA, CORP., 10) TOTAL EXHIBIT AND EXPO SOLUTIONS, INC., 11) COMS 360, INC., 12) EVENTSCAPE MANILA, INC., 13) 11 FTC ENTERPRISES, INC., 14) POST AD VENTURE INCORPORATED and 15) HALO HALO EVENTS MANAGEMENT SERVICES;

WHEREAS, for the purposes of transparency and good governance and pursuant to Section 13 of the 2016 Revised Implementing Rules and Regulations of Republic Act No. 9184, through an invitation letter dated 05 June 2020, the Bids and Awards Committee (BAC) invited three (3) observers to witness the pre-bid conference on 15 June 2020 and the opening of bids on 29 June 2020 namely; MR. CRISANTO FRIANEZA, Secretary General of Philippine Chamber of Commerce and Industry, ENGR. VIRGILIO S. SANTOS, President of Procurement Watch and MS. ANNABELLE F. DE VERA, State Auditor III/Audit Team Leader in BBS of the Commission on Audit;

WHEREAS, on 10 June 2020, the BBS-BAC issued Supplemental Bid Bulletin No. 001-2020 and posted the same in PHILGEPS, wherein the Supplemental Bid Bulletin is being issued to clarify and/or answer the query made for the conduct of the Pre-Bid Conference, in line with the current General Community Quarantine in Metro Manila, prospective bidders may opt to participate in the Pre-Bid Conference on 15 June 2020 at 10:00am via Jitsi Meet on IOS or Android or at meet.jit.si using a laptop or desktop with camera, microphones and speakers;

WHEREAS, on 13 June 2020, the BBS-BAC issued Supplemental Bid Bulletin No. 002-2020 and posted the same in PHILGEPS, wherein the Supplemental Bid Bulletin is being issued to set forth additional provisions to Section VII, Technical Specifications. Prospective bidders are reminded to submit all additional documentary requirements duly notarized and must be accompanied by a photocopy of the affiant's I.D.;

WHEREAS, the BBS-BAC scheduled the Pre-Bid Conference on 15 June 2020, 10:00AM at the BBS Training Room in order that the BBS-BAC may clarify issues which the prospective bidders might raise, the said Pre-Bid Conference was personally attended by prospective bidder from CITYNEON PHILIPPINES, INC. and was attended virtually by means of Jitsi Meet video conference application by three (3) prospective bidders, namely; 1) IMAGINIMAGE CORPORATION, 2) MANIC NIGHTNINGS EVENTS PRODUCTIONS, and 3) 11 FTC ENTERPRISES, INC.;

WHEREAS, on 20 June 2020, the BBS-BAC issued Supplemental Bid Bulletin No. 003-2020 and posted the same in PHILGEPS, wherein the Supplemental Bid Bulletin is being issued in response to various queries of prospective bidders;

WHEREAS, on 21 June 2020, the BBS-BAC issued Supplemental Bid Bulletin No. 004-2020 and posted the same in PHILGEPS, wherein the Supplemental Bid Bulletin is being issued in response to a query of a prospective bidder;

WHEREAS, three (3) prospective bidders purchased the Bidding Document, namely;

WHEREAS, on 29 June 2020, 10:00AM at the BBS Training Room, the BBS-BAC scheduled the Opening of Bids, as indicated below, three (3) prospective bidders attended and submitted their Eligibility and Technical Components Documents as well as their Financial Components Documents before the 10:00am deadline and simultaneously, the BBS-BAC conducted the Opening of Bids;

WHEREAS, the BAC proceeded to open the Eligibility and Technical Documents envelope of IMAGINIMAGE CORPORATION, its itemized contents were read aloud and subsequently shown thru the multi-media projector, during the course of the evaluation, it was discovered that it failed on one (1) of its eligibility requirements, under Section VII, Technical Specifications, Item 2. "List of names and photocopy of licenses of its Electronics and Communications Engineer (ECE), Electronics and Communications Technician (ECT) personnel that will be assigned to the project, who are highly experienced in the field of AM & FM radio operations both in studio and remote site broadcast".

WHEREAS, the requirement specifically asks for a photocopy of the license of Electronics and Communications Engineer (ECE), a photocopy of the license of Electronics and Communications Technician (ECT), instead IMAGINIMAGE CORPORATION submitted a photocopy of two (2) Electronics and Communications Engineer (ECE) licenses. This submitted document of IMAGINIMAGE CORPORATION was found to be patently insufficient;

WHEREAS, the BBS-BAC declared IMAGINIMAGE CORPORATION "INELIGIBLE". Subsequently the BBS-BAC issued a Notice of Ineligibility to the prospective bidder and informed the prospective bidder that they may file for a motion for reconsideration within three (3) calendar days upon receipt of the notice;

WHEREAS, the BBS-BAC proceeded to open the Eligibility and Technical Documents envelope of TOTAL EXHIBIT AND EXPO SOLUTIONS, INC. it was found that the enclosed technical and financial components are not separately and properly sealed contrary to the provisions of 2016 Revised Implementing Rules and Regulations of RA 9184, "Section 25 Submission and Receipt of Bids, 25.9 Unsealed or Unmarked bid envelopes shall be rejected" and the BBS-BAC rejected the bid of TOTAL EXHIBIT AND EXPO SOLUTIONS, INC. and declared "INELIGIBLE", the BBS-BAC instructed the BAC Secretariat to prepare a Notice of Ineligibility for the prospective bidder;

WHEREAS, the BBS-BAC proceeded to open the Eligibility and Technical Documents envelope of MANIC NIGHTNINGS EVENTS PRODUCTIONS, its itemized contents were read aloud and subsequently shown thru the multi-media projector and found to have passed and sufficient and was declared "ELIGIBLE";

WHEREAS, the bidding process was completed and the BBS-BAC proceeded to open the Financial Component Document of MANIC NIGHTNINGS EVENTS PRODUCTIONS in the amount of Fourteen Million Eight Hundred Seventy-Eight Thousand Pesos (PhP 14,878,000.00) and was declared by the BBS-BAC as the SINGLE RESPONSIVE BID (SRB);

WHEREAS, on the same meeting, the BBS-BAC Secretariat officially turned-over to the BAC TWG a copy of the Eligibility and Technical Documents as well as the financial document of MANIC NIGHTNINGS EVENTS PRODUCTIONS for evaluation;

WHEREAS, the BBS-BAC discussed the parameters of the post-qualification stage which includes the inspection of post-qualification documentary requirements, review of the voice talents and trade test of the technical personnel of MANIC NIGHTNINGS EVENTS PRODUCTIONS;

WHEREAS, due to the General Community Quarantine in Metro Manila as well as the registered office address of MANIC NIGHTNINGS EVENTS PRODUCTIONS is located in Davao City which is similarly under Community Quarantine and for the safety of the committee members, the BBS-BAC unanimously agreed to conduct the inspection of post-qualification documentary requirements of MANIC NIGHTNINGS EVENTS PRODUCTIONS by means of Viber video conference application and to be followed by the review of the voice talents and trade test of the technical personnel on 03 July 2020, 10:00am at the BBS Training Room;

WHEREAS, on the same day, the BAC Secretariat informed the representative of MANIC NIGHTINGS EVENTS PRODUCTIONS that the BBS-BAC agreed to conduct the inspection of all its post-qualification documents via Viber video conference and to be followed by the review of the voice talents and trade test of the technical personnel on 03 July 2020, 10:00am at the BBS Training Room;

WHEREAS, on 30 June 2020, in response to the issued Notice of Ineligibility, the BAC Secretariat received a Motion for Reconsideration letter from Ms. Ma. Mercedes F. Garcia, General Manager of IMAGINIMAGE CORPORATION;

WHEREAS, in a meeting dated 01 July 2020, the BBS-BAC has unanimously resolved to deny the Motion for Reconsideration and to stand firm that IMAGINIMAGE CORPORATION submitted a patently insufficient document and failed to meet the requirement stated in Section VII. Technical Specifications, item 2, citing the provision of the 2016 Implementing Rules and Regulations (IRR) of RA 9184, Rule IX, Section 30 Bid Evaluation Section, 30.1, which states that "bids that fail to include any requirement or are incomplete or patently insufficient shall be considered as "failed.";

WHEREAS, the BBS-BAC also unanimously denied the request of IMAGINIMAGE CORPORATION to accept the resume of their alternative member of the team who has an ECT license, citing the provision of the 2016 IRR of RA 9184, Section 55.1 of Rule XVII, which states that "The bidder shall not be allowed to submit additional documents to correct any defects in the bid submitted.";

WHEREAS on 02 July 2020, the BBS-BAC Secretariat sent a Notice of Ineligibility to TOTAL EXHIBIT AND EXPO SOLUTIONS, INC., for submitting technical and financial components that are not separately and properly sealed contrary to the provisions of GPPB NPM No. 038-2015 and the 2016 IRR of RA 9184, Section 25 Submission and Receipt of Bids, 25.9 which states that "Unsealed or Unmarked bid envelopes shall be rejected". The prospective bidder was informed that they may file for a motion for reconsideration within three (3) calendar days upon receipt of the notice;

WHEREAS on 03 July 2020, the BBS-BAC Secretariat sent the Notice of Denial to IMAGINIMAGE CORPORATION in response to their Motion for Reconsideration received by the BAC Secretariat last 30 June 2020;

WHEREAS on 03 July 2020, 10:00am at the BBS Training Room, the Composite Group of BBS BAC Members, End-User, TWG and Secretariat conducted the inspection of the post-qualification documentary requirements of MANIC NIGHTINGS EVENTS PRODUCTIONS via Viber video conference application. The Composite Group inspected all the Eligibility and Technical Components Documents and Post Qualification Documents and counterchecked the same with the video presented original documents;

WHEREAS, the Eligibility and Technical Components Documents and Post Qualification Documents were all verified and validated by the Composite Group and all were found to be true and correct and in accordance with the requirements;

WHEREAS, the other post qualification proceedings subsequently followed and the Composite Group of BBS BAC Members, TWG and Secretariat conduct an evaluation to the voice talents and technical personnel of MANIC NIGHTINGS EVENTS PRODUCTIONS;

WHEREAS, after the said proceeding, the Composite Group reported that the overall performance of the voice talents consistently surpasses all performance criteria established for each category, and its consistent effectiveness and attainments are above normal expectations and the technical personnel demonstrated highly acceptable level of knowledge and practical skills needed for the live remote broadcast aspect of the project, and therefore passed the trade test;

WHEREAS, later on the same day, the Composite Group submitted to the BBS-BAC their written evaluation reports on the voice talents and technical personnel of MANIC NIGHTINGS EVENTS PRODUCTIONS;

WHEREAS, the BBS-BAC did not receive any Motion for Reconsideration from TOTAL EXHIBIT AND EXPO SOLUTIONS, INC. as of 06 July 2020;

NOW, THEREFORE, foregoing premises considered, we the members of the Bureau of Broadcast Services-Bids and Awards Committee (BBS-BAC), hereby **RESOLVE**, as it is hereby **RESOLVED**, to declare **MANIC NIGHTINGS EVENTS PRODUCTIONS** as having the Single Calculated and Responsive Bid (SCRB) for the **Procurement of Services for the One (1) Lot – Event Organizing**; and


RESOLVE FURTHER, that the Bureau of Broadcast Services-Bids and Awards Committee (BBS-BAC) recommends to the Approving Authority the approval of this resolution, the subsequent issuance of the Notice of Award, Notice to Proceed and Letter Order to **MANIC NIGHTINGS EVENTS PRODUCTIONS** for the **Procurement of Services for the One (1) Lot – Event Organizing** in the amount of **FOURTEEN MILLION EIGHT HUNDRED SEVENTY EIGHT THOUSAND PESOS (PHP 14,878,000.00)** in accordance with the provisions of the signed Letter Order and the Guidelines under the Government Procurement Reform Act, as approved and adopted by the Government Procurement Policy Board (GPPB).


