BIDS AND AWARDS COMMITTEE (BAC) RESOLUTION DECLARING CMPT MANPOWER SERVICES AS HAVING THE SINGLE CALCULATED AND RESPONSIVE BID FOR THE ONE (1) LOT – CONTRACT FOR THE PROVISION JANITORIAL SERVICES FOR TWELVE (12) MONTHS AND RECOMMENDING TO THE APPROVING AUTHORITY THE APPROVAL THEREOF

WHEREAS, there is an approved Purchase Request (P.R.) No. **2020-11-0293** with an Approved Budget for the Contract (ABC), in the amount of *One Million Seven Hundred Seventy-Six Pesos (PhP 1,776,000.00)* as listed hereunder;

WHEREAS, the Bureau of Broadcast Services-Bids and Awards Committee (BBS-BAC) was authorized to resort to Public Bidding in accordance with the provision of Rule IV, Section 10, Competitive Bidding of the 2016 Revised IRR of R.A. 9184, otherwise known as the Government Procurement Reform Act which states that all procurement shall be done through competitive bidding, except as provided in Rule XVI of the Revised IRR of R.A. 9184;

WHEREAS, the BBS-BAC was created in accordance with BBS Memorandum Order No. 006 series of 2018;

WHEREAS, the BBS-BAC convened on 27 November 2020 to conduct a pre-procurement conference with the End-User in accordance with the provision of Section 20 of the 2016 Revised Implementing Rules and Regulations of Republic Act No. 9184;

WHEREAS, on 02 December 2020, the BBS-BAC as mandated by Republic Act No 9184, posted the Invitation to Bid for the **One (1) Lot – Contract for the Provision of Janitorial Services for twelve (12) months (Bid No. 003-2020)** in the Philippine Government Electronics Procurement System (PHILGEPS) and on conspicuous place at the premises of the BBS;

WHEREAS, in response to the said advertisement, two (2) prospective bidders viewed the Invitation to Bid at the PHILGEPS Website namely; 1) D' TRIUMPH CLEANERS & ALLIED SERVICES, INC. and 2) CMPT MANPOWER SERVICES;

WHEREAS, for the purposes of transparency and good governance and pursuant to Section 13 of the 2016 Revised Implementing Rules and Regulations of Republic Act No. 9184, the Bids and Awards Committee (BAC) invited three (3) observers to witness the pre-bid conference on 10 December 2020 and the opening of bids on 22 December 2020 namely; MR. CRISANTO FRIANEZA, Secretary General of Philippine Chamber of Commerce and Industry, ENGR. VIRGILIO S. SANTOS, President of Procurement Watch and MS. ANNABELLE F. DE VERA, State Auditor IV/Audit Team Leader in BBS of Commission on Audit;

WHEREAS, the BBS-BAC scheduled the Pre-Bid Conference on 10 December 2020 at 11:00AM in order that the BBS-BAC may clarify issues which the prospective bidders might raise, the said Pre-Bid Conference was attended physically by one (1) prospective bidder, namely; CMPT MANPOWER SERVICES;

WHEREAS, on 11 December 2020, the BBS-BAC issued Supplemental Bid Bulletin No. 001-2020 and posted the same in PHILGEPS, in response to the query made by prospective bidder CMPT MANPOWER SERVICES during the pre-bid conference, as follows;

"For the guidance of all prospective bidders, this shall serve to clarify and/or answer the query made for the conduct of the Pre-Bid Conference of Bid No. 003-2020 – One (1) Lot – Contract for the Provision of Janitorial Services for twelve (12) months.:"

In Section VII, Technical Specifications, Items 12, 13 & 14, submission of SSS, Philhealth and Pag-Ibig 1st & 2nd Quarters of 2020 Clearance Certificates, In the absence of the above-mentioned clearances, sufficient proofs of payments shall be accepted during the opening of bids.

This addendum shall form an integral part of the Bid Document"

WHEREAS, one (1) prospective bidder namely; CMPT MANPOWER SERVICES purchased the Bidding Documents;

WHEREAS, on 22 December 2020 at 11:00AM, the BBS-BAC scheduled the Opening of Bids, CMPT MANPOWER SERVICES physically attended and submitted its Eligibility and Technical Components Documents as well as its Financial Component Document before the 11:00am deadline and simultaneously, the BAC conducted the Opening of Bids

WHEREAS, the BBS-BAC opened the Eligibility and Technical Components Documents of CMPT MANPOWER SERVICES and after its itemized content were read aloud and subsequently shown thru the multi-media projector, the BBS-BAC found the eligibility and technical components documents to have PASSED and was declared ELIGIBLE;

WHEREAS, the BBS-BAC opened the Financial Component Document of CMPT MANPOWER SERVICES and was read aloud and subsequently shown thru the multi-media projector with a financial bid In the amount of *One Million Seven Hundred Seventy-Five Thousand Five Hundred Forty-One Pesos and 61/100 centavos (PhP 1,775,541.61)* and was declared by the BBS-BAC as SINGLE RESPONSIVE BID (SRB);

WHEREAS, after the declaration of SRB, the BAC Secretariat officially turned-over to the BAC TWG the Eligibility and Technical Documents as well as the Financial Component Document of CMPT MANPOWER SERVICES for evaluation;

WHEREAS, on the same meeting, the BBS-BAC informed the bidder from CMPT MANPOWER SERVICES to submit their Post-Qualification Documents within a non-extendible period of five (5) calendar days;

WHEREAS, the BBS-BAC discussed the parameters for the post-qualification stage and due to limited time, the BBS-BAC informed the bidder of CMPT MANPOWER SERVICES that the BBS-BAC will conduct the post-qualification stage on 23 December 2020 at 2:00PM;

WHEREAS, the composite group of selected BAC, TWG and Secretariat on 23 December 2020 at 12:00NN, proceeded to the office of CMPT MANPOWER SERVICES and conducted the post qualification inspection of its Eligibility and Technical Components Documents and Post Qualification Documents and counterchecked the same with the original documents. The team likewise inspected the office premises;

WHEREAS, on the same day, a meeting was held, the BBS-BAC Secretariat presented the Checklist of Post-Qualification Requirements to the BBS-BAC which were verified and validated and all were found to be true and correct and in accordance with the requirements and inspection activities. The financial document was likewise reviewed and found to be in order and in compliance with the provisions of the 2016 Revised Implementing Rules and Regulations of RA 9184;

WHEREAS, after the conduct of the post-qualification stage, the BBS-BAC declared the bid of CMPT MANPOWER SERVICES as SINGLE CALCULATED AND RESPONSIVE BID (SCRB);

NOW, THEREFORE, foregoing premises considered, we the members of the Bureau of Broadcast Services-Bids and Awards Committee (BBS-BAC), hereby **RESOLVE**, as it is hereby **RESOLVED**, to declare **CMPT MANPOWER SERVICES** as having the Single Calculated and Responsive Bid (SCRB) for the supply of seven (7) janitors for all Bureau of Broadcast Services (BBS) facilities at National Capital Region (NCR) and Cagayan de Oro City for the One (1) Lot - Contract for the Provision of Janitorial Services for twelve (12) months; and


RESOLVE FURTHER, that the Bureau of Broadcast Services-Bids and Awards Committee (BBS-BAC) recommends to the Approving Authority the approval of this resolution, the subsequent issuance of the Notice of Award, Notice to Proceed and enter into an Agreement with **CMPT MANPOWER SERVICES** for the supply of seven (7) janitors in the amount of **ONE MILLION SEVEN HUNDRED SEVENTY-FIVE THOUSAND FIVE HUNDRED FORTY-ONE PESOS AND 61/100 CENTAVOS (PHP 1,775,541.61)** in accordance with the provisions of the signed contract of services and the Guidelines under the Government Procurement Reform Act, as approved and adopted by the Government Procurement Policy Board (GPPB).




