



**INVITATION TO BID FOR THE ONE (1) LOT – CONTRACT FOR THE PROVISION OF
SECURITY AGENCY SERVICES FOR TWELVE (12) MONTHS
(BID NO. 002-2021)**

1. The Bureau of Broadcast Services (BBS), through the General Appropriations Act (GAA) of 2022 intends to apply the sum of *Twenty-Two Million Six Hundred Thirteen Thousand Pesos (PhP 22,613,000.00)* being the Approved Budget for the Contract (ABC) to payments under the contract listed below. Bids received in excess of the ABC shall be automatically rejected at bid opening.

2. The Bureau of Broadcast Services (BBS) now invites bids for the above Procurement Project. Delivery of the Goods is required by twelve (12) months. Bidders should have completed, within five (5) years from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).
3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary “*pass/fail*” criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.
 - a. Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA No. 5183.

Bid opening shall be on **9:00am (BBS Bundy Clock Time), 01 December 2021** at the **Bureau of Broadcast Services, Training Room, 4th Floor, PIA Building, Visayas Avenue, Quezon City** and through video conferencing/webcasting via **Zoom application**, download the **Zoom app** on **App Store on IOS** or through **Google Play**.
