**BIDS AND AWARDS COMMITTEE (BAC) RESOLUTION DECLARING COMPOSITE TECHNOLOGY, INC. AS THE TECHNICALLY, LEGALLY AND FINANCIALLY CAPABLE SUPPLIER AND RECOMMENDING TO THE APPROVING AUTHORITY THE APPROVAL THEREOF**

**WHEREAS**, there is an approved *Job Order (J.O.)* No. **2022-06-0043** with an Approved Budget for the Contract (ABC) of **Fifty-Six Thousand Pesos (PhP 56,000.00)** for the procurement of the following items below;

**WHEREAS**, the Bids and Awards Committee (BAC) was created in accordance with BBS Memorandum Order No. 006 series of 2018;

**WHEREAS**, the said *purchase request/job order* is included in the Annual Procurement Plan of the Philippine Broadcasting Service- Bureau of Broadcast Services (PBS-BBS) for 2022;

**WHEREAS**, the Bids and Awards Committee was authorized to resort to alternative method of procurement in accordance with provision of Article XVI, Section 50; which states that **DIRECT CONTRACTING** or single source procurement is a method of procurement of goods that does not require elaborate Bidding Documents. The supplier is simply asked to submit a price quotation or a pro-forma invoice together with the condition of sale. Direct Contracting may be resorted under any of the following conditions:

- Procurement of goods of proprietary nature which can be obtained only from the proprietary source;
- When the procurement of critical components from a specific supplier is a condition precedent to hold a contractor to guarantee its project performance, in accordance with the provisions of its contract;
- Those sold by an exclusive dealer or manufacturer which does not have sub-dealers selling at lower prices and for which no suitable substitute can be obtained at more advantageous terms;

**WHEREAS**, the End-User conducted a survey to determine the probable supplier that could undertake the procurement through direct contracting and considered **COMPOSITE TECHNOLOGY, INC.** as the probable direct supplier;

**WHEREAS**, the BAC received from the End-User the purchase request/job order and other appropriate document/s that will justify the necessity of the item to be procured and confirming the existence and veracity of the grounds to resort to Direct Contracting procurement;

**WHEREAS**, the BBS-BAC upon review of the submitted documents of the End-User recommended to the HOPE the mode of procurement and execute the said request;

**WHEREAS**, the BBS-BAC agreed to proceed with the finalization of the Request for Quotation (RFQ) and the terms and conditions of the procurement;

**WHEREAS**, the BBS-BAC undertook a negotiation with **COMPOSITE TECHNOLOGY, INC.** to determine that the supplier is technically, legally and financially capable to deliver the Goods at the most advantageous price and contract;

**WHEREAS**, **COMPOSITE TECHNOLOGY, INC.** submitted their accomplished RFQ with a financial offer in the amount of **Fifty-Six Thousand Pesos (PhP 56,000.00) VAT inclusive** and other required documents;

1. To declare *COMPOSITE TECHNOLOGY, INC.* as the supplier that is technically, legally and financially capable to perform the above-mentioned requirement for the procurement of the abovementioned items; and
2. To recommend to the HOPE the award of the Letter Order to *COMPOSITE TECHNOLOGY, INC.* for having submitted the SCRQ with a contract price in the amount of **Fifty-Six Thousand Pesos (PhP 56,000.00)**.
