**BIDS AND AWARDS COMMITTEE (BAC) RESOLUTION DECLARING 168 SECURITY, INC. AS HAVING THE SINGLE CALCULATED AND RESPONSIVE BID FOR THE ONE (1) LOT – CONTRACT FOR THE PROVISION OF SECURITY AGENCY SERVICES FOR TWELVE (12) MONTHS AND RECOMMENDING TO THE APPROVING AUTHORITY THE APPROVAL THEREOF**

**WHEREAS**, there is an approved Purchase Request (P.R.) No. **2023-10-0311J**, with an Approved Budget for the Contract (ABC), in the amount of **Twenty-Seven Million One Hundred Thousand Pesos (PhP 27,100,000.00)** as listed hereunder;

**WHEREAS**, the Bureau of Broadcast Services-Bids and Awards Committee (BBS-BAC) was authorized to resort to Public Bidding in accordance with the provision of Rule IV, **Section 10, Competitive Bidding** of the 2016 Revised IRR of R.A. 9184, otherwise known as the Government Procurement Reform Act which states that all procurement shall be done through competitive bidding, except as provided in Rule XVI of the Revised IRR of R.A. 9184;

**WHEREAS**, the BBS-BAC was created in accordance with BBS Special Order No. 046 series of 2023 dated 07 March 2023;

**WHEREAS**, the said *Purchase Request* is included in the Annual Procurement Plan of the Philippine Broadcasting Service-Bureau Services (PBS-BBS) for 2024;

**WHEREAS**, the BBS-BAC convened on **11 October 2023, 10:00am** at the BBS Training Room to conduct a pre-procurement conference with the End-User in accordance with the provision of Section 20 of the 2016 Revised Implementing Rules and Regulations of Republic Act No. 9184;

**WHEREAS**, on **26 October 2023**, the BBS-BAC as mandated by Republic Act No 9184, posted the Invitation to Bid for the **One (1) Lot – Contract for the Provision of Security Agency Services for twelve (12) months (Bid No. 001-2023)** in the Philippine Government Electronics Procurement System (PHILGEPS), on conspicuous place at the premises of the BBS and posted the same in the website of the Bureau of Broadcast Services;

**WHEREAS**, in response to the said advertisement, six (6) prospective bidders viewed the Invitation to Bid at the PHILGEPS Website namely; 1) ABC-RMO SECURITY AND INVESTIGATION, INC. 2) DBPSC SECURITY SERVICE INCORPORATED 3) EX-BATAAN SECURITY AGENCY, INC. 4) ARVITER TOP OF THE LINE SEC. INVEST. SPECIALIST, 5) NORTHPOINT SECURITY AND INVESTIGATION AGENCY, INC. and 6) INFOBAHN COMMUNICATIONS, INC.;

**WHEREAS**, on **26 October 2023 and 28 October 2023** for the purposes of transparency and good governance and pursuant to Section 10 of the Revised Implementing Rules and Regulations of Republic Act No. 9184, the Bids and Awards Committee (BAC) invited three (3) observers to witness the pre-bid conference and the opening of bids, namely; MR. CRISANTO FRIANEZA, Secretary-General of Philippine Chamber of Commerce and Industry, MR. AMADOR ASTUDILLO, President of Procurement Watch and MS. ESTRELLITA M. AGUILAR, Audit Team Leader in BBS of the Commission on Audit;

**WHEREAS**, on 26 October 2023, **168 SECURITY, INC.**, purchased the bidding document;

**WHEREAS**, the BBS-BAC scheduled the Pre-Bid Conference on **07 November 2023, 10:00am** at the BBS Training Room in order that the BBS-BAC may clarify issues which the prospective bidder/s might raise, three (3) prospective bidders attended the pre-bid conference namely; 1) NONAGON SECURITY SERVICES, INC., 2) ULTRA SECURITY SERVICES, INC., and 3) 168 SECURITY, INC.;

**WHEREAS**, on **11 November 2023**, the BBS-BAC issued Supplemental/Bid Bulletin No. 001 to clarify certain provision of the bidding documents, to wit:

*"In compliance with the latest revised cost distribution of the Philippine Association Detective and Protective Agency Operators (PADPAO) rates nationwide, all prospective bidders must comply with the updated rates issued as of October 2023"*

**WHEREAS**, on **21 November 2023** at **10:00am**, the BBS-BAC scheduled the Opening of Bids, **168 SECURITY, INC.** physically attended and submitted their sealed envelope containing the Eligibility and Technical Components Documents as well as their Financial Component Document before the given deadline set by the BBS-BAC at 10:00am and simultaneously, the BAC conducted the Opening of Bids;

**WHEREAS**, BBS-Commission on Audit (COA) representative MS. MARYLE R. GLORIOSO, attended the Opening of Bids as an observer;

**WHEREAS**, the BBS-BAC opened the Eligibility and Technical Components Documents of **168 SECURITY, INC.** and after its itemized content were read aloud and subsequently shown thru the multi-media projector, the BBS-BAC found the eligibility and technical components documents to have PASSED and was declared ELIGIBLE;

**WHEREAS**, the BBS-BAC opened the Financial Component Document of **168 SECURITY, INC.** and was read aloud and subsequently shown thru the multi-media projector with a financial bid In the amount of **Twenty-Seven Million Ninety-Two Thousand Nine Hundred Eighty-Nine Pesos and 91/100 centavos (PhP 27,092,989.91)** and was declared by the BBS-BAC as SINGLE RESPONSIVE BID (SRB);

**WHEREAS**, after the declaration of SRB, the BAC Secretariat officially turned-over to the BAC-TWG the Eligibility and Technical Documents as well as the Financial Component Document of **168 SECURITY, INC.** for bid evaluation;

**WHEREAS**, on the same meeting, the BBS-BAC sets the schedule of Bid Evaluation presentation on **24 November 2023, 1:30pm** at the BBS Training Room and Post-Qualification Inspection on **29 November 2023, 10:00am** at 168 Security, Inc., Rm, 2B, 2<sup>nd</sup> Floor Hizon Building, 29 Quezon Avenue, Quezon City and invited three (3) observers to witness the abovementioned procurement activities, namely; MR. CRISANTO FRIANEZA, Secretary-General of Philippine Chamber of Commerce and Industry, MR. AMADOR ASTUDILLO, President of Procurement Watch and MS. ESTRELLITA M. AGUILAR, Audit Team Leader in BBS of the Commission on Audit;

**WHEREAS**, on **24 November 2023**, the BAC Secretariat informed the bidder from **168 SECURITY, INC.** to submit their Post-Qualification Documents within a non-extendible period of five (5) calendar days and to prepare the original documents for the conduct of the post-qualification inspection stage on 29 November 2023 at their office premises;

**WHEREAS**, the composite group of selected BAC, TWG and Secretariat on **29 November 2023** at **10:00am**, proceeded to the office of **168 SECURITY, INC.** and conducted the post qualification inspection of its Eligibility and Technical Components Documents and Post Qualification Documents and counterchecked the same with the presented original documents. Likewise, the composite group inspected their office premises, training facility and armory;

**WHEREAS**, after all the eligibility and technical components documents and post-qualification documents were verified and validated and all were found to be true and correct and in accordance with the requirements and inspection activities. The BBS-BAC Post-Qualification Composite Group declared **168 SECURITY, INC.** to have PASSED the post-qualification requirements and inspection activities;

**WHEREAS**, the composite group submitted to the BBS-BAC the accomplished Checklist of Post-Qualification Requirements, which were all been verified and validated and all were found to be true and correct. The financial document was likewise reviewed and found to be in order and in compliance with the provisions of the 2016 Revised Implementing Rules and Regulations of RA 9184;

**NOW, THEREFORE**, foregoing premises considered, we the members of the Bureau of Broadcast Services-Bids and Awards Committee (BBS-BAC), hereby **RESOLVE**, as it is hereby **RESOLVED**, to declare **168 SECURITY INC.** as having the Single Calculated and Responsive Bid (SCRB) for the supply of Sixty-two (62) security guards for all Bureau of Broadcast Services (BBS) facilities nationwide (NCR, CAR, Region I, II, III, IV, V, VI, VII, VIII, IX, X, XI, XIII and BARMM) for the **One (1) Lot - Contract for the Provision of Security Agency Services for twelve (12) months**; and

**RESOLVE FURTHER**, that the Bureau of Broadcast Services-Bids and Awards Committee (BBS-BAC) recommends to the Approving Authority the approval of this resolution, the subsequent issuance of the Notice of Award, Notice to Proceed and to enter into a Contract of Agreement with **168 SECURITY INC.** for the supply of Sixty-three (63) security guards in the amount of **Twenty-Seven Million Ninety-Two Thousand Nine Hundred Eighty-Nine Pesos and 91/100 centavos (PhP 27,092,989.91)** in accordance with the provisions of the signed contract of services and the Guidelines under the Government Procurement Reform Act and its revised IRR, as approved and adopted by the Government Procurement Policy Board (GPPB).
