**BIDS AND AWARDS COMMITTEE (BAC) RESOLUTION FOR THE CANCELLATION OF THE PUBLIC BIDDING FOR THE ONE (1) LOT – SUPPLY AND DELIVERY OF MOTOR VEHICLES (BID NO. 001-2024) AND RECOMMENDING TO THE APPROVING AUTHORITY THE APPROVAL THEREOF**

**WHEREAS**, the Bids and Awards Committee (BAC) posted the invitation to bid for Bid No. 001-2024 – One (1) Lot – Supply and Delivery of Motor Vehicles at the Philippine Government Electronic Procurement System (PhilGEPS) Website, Presidential Broadcast Service-Bureau of Broadcast Services (PBS-BBS) Website and at the conspicuous place in PBS-BBS Central Office on May 20, 2024;

**WHEREAS**, the Approved Budget for the Contract (ABC) is Sixteen Million Thirty-Five Thousand Pesos (PhP 16,035,000.00);

**WHEREAS**, the Bids and Awards Committee (BAC) held a Pre-bid Conference last May 28, 2024, 10:00AM at the BBS Training Room and was attended by five (5) prospective bidders, namely: a) Toyota North EDSA, b) Toyota Pasong Tamo, c) Toyota Marilao, d) Toyota Fairview and e) Nissan/SGV Auto Group;

**WHEREAS**, the BAC scheduled the opening and submission/receipt of bids on June 11, 2024, 10:00AM at the BBS Training Room;

**WHEREAS**, during the BAC meeting on June 03, 2024, 10:00AM at the BBS Training Room issues and concerns were raised about the procurement of motor vehicles and there are some provisions in the bidding document that need to be modified/revised;

**WHEREAS**, after thorough deliberation and discussion, the Bids and Awards Committee agreed for the cancellation of the remaining procurement activities of Bid No. 001-2024 – One (1) Lot – Supply and Delivery of Motor Vehicles and shall be for further study;

**NOW THEREFORE**, we the Members of the Bids and Awards Committee (BAC) hereby **RESOLVES**, as it is hereby **RESOLVED**;

- 1) To recommend the cancellation of the bidding process for Bid No. 001-2024 – One (1) Lot – Supply and Delivery of Motor Vehicles;
- 2) To Post this BAC Resolution in the PHILGEPS Website, PBS-BBS Website and in the conspicuous bulletin board of PBS-BBS Central Office; and
- 3) The re-bidding of One (1) Lot – Supply and Delivery of Motor Vehicles after further studying and review of the technical specifications, ABC and other requirements as mandated by RA 9184 and its IRR;
