BIDS AND AWARDS COMMITTEE (BAC) RESOLUTION DECLARING 90 DEGREES NORTH, INC. AS HAVING THE SINGLE CALCULATED AND RESPONSIVE BID (SCRB) FOR THE ONE (1) LOT – SUPPLY AND DELIVERY OF INFORMATION SYSTEM STRATEGIC PLAN (ISSP) VARIOUS BROADCAST EQUIPMENT, BROADCAST AUTOMATION / DISASTER ALERT SYSTEM AND COMPONENTS AND RECOMMENDING TO THE APPROVING AUTHORITY THE APPROVAL THEREOF

WHEREAS, there is an approved Purchase Request (P.R.) Nos. 2024-07-0244 & 2024-07-0245 with an Approved Budget for the Contract (ABC) in the amount of *Nine Million One Hundred Ninety-Four Thousand Pesos (PhP 9,194,000.00)* as listed hereunder;

WHEREAS, the Bureau of Broadcast Services-Bids and Awards Committee (BBS-BAC) was authorized to resort to Public Bidding in accordance with the provision of Rule IV, Section 10, Competitive Bidding of the 2016 Revised IRR of R.A. 9184, otherwise known as

the Government Procurement Reform Act which states that all procurement shall be done through competitive bidding, except as provided in Rule XVI of the Revised IRR of R.A. 9184;

WHEREAS, the BBS-BAC was created in accordance with BBS Special Order No. 046 series of 2024 dated 31 May 2024;

WHEREAS, the BBS-BAC convened on **10 July 2024** at the BBS Training Room to conduct a pre-procurement conference with the End-User in accordance with the provision of Section 20 of the 2016 Revised Implementing Rules and Regulations of Republic Act No. 9184;

WHEREAS, on **16 July 2024**, the BBS-BAC as mandated by Republic Act No 9184, posted the Invitation to Bid for the **One (1) Lot – Supply and Delivery of Information System Strategic Plan (ISSP) Various Broadcast Equipment, Broadcast Automation / Disaster Alert System and Components (Bid No. 002-2024)** in the Philippine Government Electronics Procurement System (PHILGEPS), on conspicuous place at the premises of the BBS and posted the same in the website of the Bureau of Broadcast Services;

WHEREAS, in response to the said advertisement, eight (8) prospective bidders viewed the Invitation to Bid at the PHILGEPS Website namely; 1) MICRODATA SYSTEMS AND MANAGEMENT, INC., 2) INFOBANN COMMUNICATIONS, INC., 3) MARA LINUX AND BUSINESS SOLUTIONS, INC., 4) 90 DEGREES NORRTH, INC., 5) SAGESOFT SOLUTIONS, INC., 6) COMWORKS, INC., 7) 8BTSI CORP., and 8) BROADTECH CORPORATION;

WHEREAS, on **16 July 2024** for the purposes of transparency and good governance and pursuant to Section 10 of the Revised Implementing Rules and Regulations of Republic Act No. 9184, the Bids and Awards Committee (BAC) invited three (3) observers to witness the pre-bid conference and the opening of bids, namely; MR. CRISANTO FRIANEZA, Secretary General of Philippine Chamber of Commerce and Industry, , MR. AMADOR ASTUDILLO, President of Procurement Watch and MS. ESTRELLITA M. AGUILAR, Audit Team Leader in BBS of Commission on Audit;

WHEREAS, in view of the suspension of work in government offices due to Typhoon Carina on July 24, 2024, the BBS-BAC at 4:22AM of July 24, 2024 issued Supplemental Bid Bulletin No. 001-2024 for the cancellation of the pre-bid conference of Bid No. 002-2024 on July 24, 2024 and re-scheduling the pre-bid conference on July 25, 2024 at 10:00AM;

WHEREAS, Malacanang once again suspend work in government offices on July 25,2024 due to Typhoon Carina, the BBS-BAC at 8:09PM of July 24, 2024 issued Supplemental Bid Bulletin No. 002-2024 for the cancellation of the scheduled pre-bid conference and re-scheduling the pre-bid conference and submission and opening of bids of Bid No. 002-2024, as follows:

WHEREAS, the BBS-BAC on August 24, 2024 posted the Supplemental Bid Bulletin in the Philippine Government Electronics Procurement System (PHILGEPS), website of the Bureau of Broadcast Services, and on August 26, 2024 posted at conspicuous place at the premises of the BBS;

WHEREAS, on **24 July 2024**, for the purposes of transparency and good governance and pursuant to Section 10 of RA 9184 Revised IRR, the BBS-BAC provided a copy of the supplemental bid bulletin to the three (3) invited observers to witness the pre-bid conference and the opening of bids, namely; MR. CRISANTO FRIANEZA, Secretary General of Philippine Chamber of Commerce and Industry, , MR. AMADOR ASTUDILLO, President of Procurement Watch and MS. ESTRELLITA M. AGUILAR, Audit Team Leader in BBS of Commission on Audit;

WHEREAS, the BBS-BAC scheduled the Pre-Bid Conference on **31 July 2024**, 1:30PM at the BBS Training Room in order that the BBS-BAC may clarify issues which the prospective bidder/s might raise. One (1) prospective bidder attended the pre-bid conference namely; 1) 90 DEGREES NORTH, INC.;

WHEREAS, invited observers from the Philippine Chamber of Commerce and Industry, Procurement Watch, and BBS-Commission on Audit (COA) BBS Resident Auditor did not attend the pre-bid conference proceeding;

WHEREAS, one (1) prospective bidder purchased the bidding document namely; 1) 90 DEGREES NORTH, INC.;

WHEREAS, on **14 August 2024** at 10:00AM, the BBS-BAC scheduled the Opening of Bids, **90 DEGREES NORTH, INC.** physically attended and submitted their Eligibility and Technical Components Documents as well as their Financial Component Document at 9:17AM before the 10:00AM deadline and simultaneously, the BAC conducted the Opening of Bids;

WHEREAS, Commission on Audit (COA) BBS Resident Auditor representative Ms. Paula Camacho attended the opening of bids, while other invited observers from the Philippine Chamber of Commerce and Industry, and Procurement Watch did not attend opening of bids proceeding;

WHEREAS, the BBS-BAC opened the Eligibility and Technical Components Documents of **90 DEGREES NORTH, INC.** and after its itemized content were read aloud and subsequently shown thru the multi-media projector, the BBS-BAC found the eligibility and technical components documents to have PASSED and was declared ELIGIBLE;

WHEREAS, the BBS-BAC opened the Financial Component Document of **90 DEGREES NORTH, INC.** and was read aloud and subsequently shown thru the multi-media projector with a financial bid In the amount of **Nine Million One Hundred Ninety-Three Thousand Nine Hundred Pesos (Php 9,193,900.00)** and the bid of **90 DEGREES NORTH, INC.** was declared by the BBS-BAC as SINGLE RESPONSIVE BID (SRB);

WHEREAS, after the declaration of SRB, the BAC Secretariat officially turned-over to the BAC-TWG the Eligibility and Technical Documents as well as the Financial Component Document of **90 DEGREES NORTH, INC.**, for evaluation;

WHEREAS, on the same meeting, the BBS-BAC scheduled **90 DEGREES NORTH, INC.**, bid evaluation and post-qualification activities respectively, bid evaluation on August 27, 2024, 9:00AM at the BBS Training Room and Post-Qualification and Inspection Activity on

August 27, 2024, 11:00AM at the office of 90 DEGREES NORTH, INC., in 509 Emerald Court Building, No. 54 Road 8 corner Road 3, Project 6, Quezon City;

WHEREAS, the BAC Secretariat informed Ms. Ashley Queen Medina, representative of **90 DEGREES NORTH, INC.**, that a composite group of BAC, TWG & Secretariat will conduct a post-qualification and inspection activity at their office on August 27, 2024 at 11:00AM;

WHEREAS, for the purposes of transparency and good governance and pursuant to Section 10 of the Revised IRR of RA 9184, the BBS-BAC on August 15, 2024 invited observers to witness the conduct of bid evaluation and post-qualification and inspection activity, namely; MR. CRISANTO FRIANEZA, Secretary General of Philippine Chamber of Commerce and Industry, , MR. AMADOR ASTUDILLO, President of Procurement Watch and MS. ESTRELLITA M. AGUILAR, Audit Team Leader in BBS of Commission on Audit;

WHEREAS, the BBS-BAC scheduled the Bid Evaluation on **27 August 2024**, 9:00AM at the BBS Training Room, after thorough review and evaluation of the technical documents, the BAC-TWG have found the documents of **90 DEGREES NORTH, INC.**, in order and compliant while upon checking and calculating the submitted financial documents, the BAC-TWG found that there is a difference of two (2) centavos between the bid form with an amount of Php 9,193,900.00 and the itemize price schedule with an amount of Php 9,193,899.98;

WHEREAS, the BBS-BAC upon deliberation unanimously agreed to adopt the findings of BAC-TWG and set the bid price of 90 DEGREES NORTH, INC., to the calculated amount of Nine Million One Hundred Ninety-Three Thousand Eight Hundred Ninety-Nine Pesos and 98/100 CentavoS (PHP 9,193,899.98);

WHEREAS, invited observers from Philippine Chamber of Commerce and Industry, Procurement Watch, and BBS Resident Auditor from the Commission on Audit (COA) did not attend the bid evaluation;

WHEREAS, after the bid evaluation, the BBS-BAC composite group of selected BAC, TWG and Secretariat on **27 August 2024** at 11:00AM, proceeded to the office of **90 DEGREES NORTH, INC.**, in 509 Emerald Court Building, No. 54 Road 8 corner Road 3, Project 6, Quezon City and conducted the post qualification inspection of its Eligibility and Technical Components Documents and Post Qualification Documents and counterchecked the same with the presented original documents;

WHEREAS, invited observers from the Philippine Chamber of Commerce and Industry, Procurement Watch, and BBS Resident Auditor from the Commission on Audit (COA) did not attend the post-qualification activity;

WHEREAS, after all the eligibility and technical components documents and post-qualification documents were verified and validated and all were found to be true and correct and in accordance with the requirements and inspection activities by the BBS-BAC Composite Group;

WHEREAS, the BBS-BAC Composite Group declared **90 DEGREES NORTH, INC.**, to have PASSED the post-qualification requirements and inspection activities;


WHEREAS, the composite group submitted to the BBS-BAC the accomplished Checklist of Post-Qualification Requirements, which were all been verified and validated and all were found to be true and correct. The financial document was likewise reviewed and found to be in order and in compliance with the provisions of the 2016 Revised Implementing Rules and Regulations of RA 9184;

NOW, THEREFORE, foregoing premises considered, we the members of the Bureau of Broadcast Services-Bids and Awards Committee (BBS-BAC), hereby **RESOLVE**, as it is hereby **RESOLVED**, to declare **90 DEGREES NORTH, INC.** as having the **SINGLE CALCULATED AND RESPONSIVE BID (SCRB)** for the **One (1) Lot – Supply and Delivery of Information System Strategic Plan (ISSP) Various Broadcast Equipment, Broadcast Automation / Disaster Alert System and Components** and

RESOLVE FURTHER, that the Bureau of Broadcast Services-Bids and Awards Committee (BBS-BAC) recommends to the Approving Authority the approval of this resolution, the subsequent issuance of the Notice of Award, Notice to Proceed and Purchase Order with **90 DEGREES NORTH, INC.** for the **One (1) Lot – Supply and Delivery of Information System Strategic Plan (ISSP) Various Broadcast Equipment, Broadcast Automation / Disaster Alert System and Components** in the amount of **Nine Million One Hundred Ninety-Three Thousand Eight Hundred Ninety-Nine Pesos and 98/100 centavos (Php 9,193,899.98)** in accordance with the provisions of the signed Purchase Order and the Guidelines under the Government Procurement Reform Act, as approved and adopted by the Government Procurement Policy Board (GPPB).
