

BAC RESOLUTION No. 229 Series of 2024

BIDS AND AWARDS COMMITTEE (BAC) RESOLUTION DECLARING 8BTSI CORPORATION AS THE TECHNICALLY, LEGALLY AND FINANCIALLY CAPABLE SUPPLIER AND RECOMMENDING TO THE APPROVING AUTHORITY THE APPROVAL THEREOF

WHEREAS, there is an approved Purxhase Request (P.R.) No. 2024-09-0314H with an Approved Budget for the Contract (ABC) of One Million Thirty-Three Thousand Three Hundred Pesos (PhP 1,033,300.00) for the procurement of the following items below;

WHEREAS, the Bids and Awards Committee (BAC) was created in accordance with BBS Special Order No. 085-A series of 2024 dated 30 September 2024;

WHEREAS, the said purchase request/job order is included in the Annual Procurement Plan of the Presidential Broadcast Service- Bureau of Broadcast Services (PBS-BBS) for 2024;

WHEREAS, the Bids and Awards Committee was authorized to resort to alternative method of procurement in accordance with provision of Article XVI, Section 50; which states that DIRECT CONTRACTING or single source procurement is a method of procurement of goods that does not require elaborate Bidding Documents. The supplier is simply asked to submit a price quotation or a pro-forma invoice together with the condition of sale. The offer may be accepted immediately or after some negotiations. Direct Contracting may be resorted under any of the following conditions:

- Procurement of goods of proprietary nature which can be obtained only from the proprietary source, i.e., when patents, trade secrets, and copyrights prohibit others from manufacturing the same item;
- b. When the procurement of critical components from a specific supplier is a condition precedent to hold a contractor to guarantee its project performance, in accordance with the provisions of its contract; or
- c. Those sold by an exclusive dealer or manufacturer which does not have sub-dealers selling at lower prices and for which no suitable substitute can be obtained at more advantageous terms to the government.

WHEREAS, to justify the need to procure through the Direct Contracting method, the End-User should conduct a survey of the industry and determine the supply source. In all cases where Direct Contracting is contemplated, the survey must be conducted prior to the commencement of the procurement process. Moreover, the End-User must justify the necessity for an item that may only be procured through Direct Contracting, and it must be able to prove that there is no suitable substitute in the market that can be obtained at more advantageous terms.

WHEREAS, the End-User conducted a survey to determine the probable supplier that can supply the item/s and could undertake the procurement through direct contracting and considered 8BTSI CORPORATION as the probable direct

WHEREAS, the BBS-BAC received from the End-User the purchase request/job order and other appropriate document/s that will justify the necessity of the item to be procured and confirming the existence and veracity of the grounds to resort to Direct Contracting procurement;

WHEREAS, the BBS-BAC upon review of the submitted documents of the End-User recommended to the HOPE the mode of procurement and execute the said request;

WHEREAS, the BBS-BAC agreed to proceed with the finalization of the Request for Quotation (RFQ) together with the terms and conditions of the procurement and send the same to the identified probable supplier of the end-user;

WHEREAS, the BBS-BAC undertook a negotiation with 8BTSI CORPORATION to determine that the supplier is technically, legally and financially capable to deliver the Goods at the most advantageous price and contract;

WHEREAS, 8BTSI CORPORATION submitted their accomplished RFQ with a financial offer in the amount of *One Million Thirty-Three Thousand Three Hundred Pesos (PhP* 1,033,300.00) and other required documents;

NOW THEREFORE, the members of the Bids and Awards Committee hereby RESOLVE as it is hereby RESOLVED;

- To declare 8BTSI CORPORATION as the supplier that is the above-mentioned requirement for the procurement of the abovementioned items; and
- To recommend to the HOPE the award of the Purchase Order to 8BTSI CORPORATION for having submitted the SCRQ with a contract price in the amount of One Million Thirty-Three Thousand Three Hundred Pesos (PhP 1,033,300.00)
